

## PERSONAL DATA PROCEESSING CONSENT

according to the Article 69(1a) and the Article 7 of the Regulation (EU) and of the Council No 2016/679 of April 27 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data that repeals the Regulation 95/46/ES (the Regulation on general data protection)

I hereby grant a consent to the controller, **IT – Impulse Ltd., Letná 42, 040 01 Košice** (hereinafter referred to as the Controller) to process my personal data for the purpose of managing a database of job seekers that have submitted an application voluntarily, not as a response to a call for a new job opening, to the following extent:

- first name, last name, birth name, title
- education,
- work experience,
- employment, position, status,
- course of previous employments,
- date of birth, place of birth, county of birth,
- permanent residence, temporary residence, previous residence
- marital status,
- phone number,
- ID card No., or passport No.,
- additional ID data,
- criminal records,
- certificate verifying obtained education in stated profession,
- additional data stated in resume.

This consent to process my personal data is freely given, specific, informed and definite indication of my free will granted for the period of 36 months of the date of submitting job seeking application. Subsequent to abovementioned deadline your personal data shall be mechanically destroyed (shredded) and shall no further be processed in any other database.

By granting the consent I also draw my attention to the following:

- My personal data will not be provided to beneficiaries.
- My personal data, provided voluntarily, shall be kept throughout the period of validity of the consent and shall in no circumstance be used for purposes other than those for which it was collected.
- From the Controller, as the data subject, I have a right to request an access to my personal data to edit or delete it, I have a right to restrict the processing or to object to processing as well as right to transfer data.
- In duly justified case, as the data subject, I have a right to lodge a complaint with a supervisory authority, the Office for Personal Data Protection of the Slovak Republic.
- I understand an international transfer of personal data to a third country shall not take place.
- I understand the processing is automated, including profiling.

As the data subject, I have a right to revoke the consent, even prior to the date of its expiry, as follows:

- c) Send a written request to the Controller's address stating „GDPR – Consent Revocation“ on the envelope

The consent revocation shall not affect the lawfulness of processing based on consent before its revocation.
